



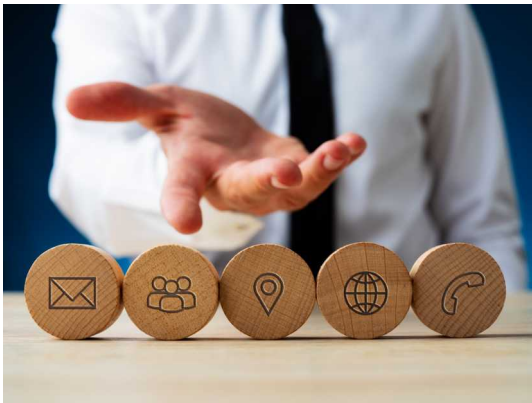
## NEWSLETTER - JUNE 2021

The purpose of this Forum is to share experiences and best practice on the implementation of measures to counter BEPS. This year's Forum meeting will focus on the following aspects of the BEPS Action Plan:

- Tax challenges arising from digitalisation of the economy (Action 1);
- Effective treatment of information on tax rulings subject to the automatic exchange between tax administrations (Action 5);
- Mandatory Disclosure Rules (Action 12);
- Country-by-Country Reporting (Action 13).

debate about the challenges of using data in the fight against tax evasion and aggressive tax planning.

Particular focus of the Technical Session of IOTA General Assembly will be on:

- Enhancing the effective use of domestic and cross-border data exchange for tackling offshore tax evasion
- Effective deployment of new technology (artificial intelligence, blockchain, etc.) for data processing and management
- Ensuring the quality of data exchanged between tax administrations
- Implications of data protection and data confidentiality on the transfer and usage of data
- Concerns and difficulties faced by businesses in complying with reporting, due diligence and secure exchange of fiscal information requirements

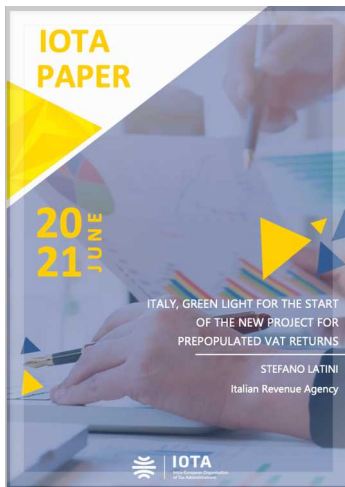

### **ITALY, GREEN LIGHT FOR THE START OF THE NEW PROJECT FOR PREPOPULATED VAT RETURNS**

This report was published on 23rd April 2021. It was prepared by the Subgroup of the Forum on Combating VAT Fraud and it sheds light on VAT fraud schemes emerging in the digital economy.

The report uses data provided by 32 IOTA member tax administrations participating in a country survey conducted in January–March 2020. The report aims to raise awareness about new types of VAT fraud schemes emerging in the digital economy as well as to identify examples of the effective and appropriate use of available databases, along with the international cooperation in action.
